**No new service will be authorized between October 1 and April 30 due to the line's exposure to freezing temperatures (TTWD WSC & U Ordinance, SECTION A. & B.)**

The applicant must schedule the new service connection with the TTWD Plumbing Contractor at least one week before the requested connection date. All applications and fees must be received by Sept 15 for hook-up to occur before Oct 1.

## WATER UTILITY SERVICE RESPONSIBILITIES:

The TTWD will supply materials and installation of the saddle onto the water main, the copper line from the saddle to the curb stop valve, the curb stop valve, and the copper line from the curb stop valve to the meter pit and the meter pit.

The meter installation is included in the meter fee and will be installed by TTWD.

Once the new installation is completed, the TTWD will maintain the water service to the curb stop valve.

## PROPERTY OWNER RESPONSIBILITIES:

**The property owner will supply all excavation** (TTWD WSC & U Ordinance, SECTION C.22.) **and any other materials** needed to complete the new service. In addition, the property owner will supply and install all necessary fittings and copper lines or a minimum of 200-PSI polyline for the service from the meter pit to the home.

The TTWD Plumbing Contractor will inspect all work before backfilling the excavation. (TTWD WSC & U Ordinance, SECTION E.24.25.26.) The property owner maintains the water service from the curb stop valve and box into the home.

\*NEW SERVICE WILL BE TURNED ON ONLY BY TTWD AFTER ALL INSPECTIONS HAVE BEEN MET.

\*ALL SERVICE LINES MUST INCLUDE A LOCATION WIRE.

\*Monthly service fee (\$82 Residential / \$107 Vacation Rental) begins the month the service is turned on. A usage fee of \$4 per every 1,000 gallons will be billed monthly along with the monthly service fee.
